EDUCATIONAL VISIT TO: Miller and Carter, Cannock

Dear Parent/Person with Parental Responsibility,

It is proposed to arrange a visit to Miller and Carter in Cannock on Wednesday, 13th July 2022 leaving school at 12:00 PM. The predicted time of return is 3:00 PM. The visit is open to Year 11 GCSE students from the Hospitality and Catering Department. The purpose of this visit is to experience and explore a chain restaurant lunch menu, how flavours are combined and how food is plated to meet the needs of the customer. Please return the attached consent form by Wednesday, 29th June 2022 to enable the visit arrangements to be completed and confirmed.

We will use the school minibus as our transport for this visit, so a small payment is required for travel. A breakdown of this is shown below:

- 2-course lunch menu and one soft drink: £15.50
- Travel: £2
- Total: £17.50

Students will be travelling by minibus and your child will be expected to be responsible enough to wear any seatbelt provided until informed it may be released. Participants attending this visit will need to have a record of good behaviour and demonstrate that they can obey safety and other rules. Anyone whose behaviour becomes unacceptable after the trip has been booked may be excluded or required to return home early and any expenses incurred will be the responsibility of their parents.

As food and a drink is covered in the total cost and paid in advance, no further food or drinks or money need to be brought on this visit. Due to timings of the restaurant and timings of the minibus, further or additional food should be purchased at the restaurant.

The following activities are included:

- Enjoy a 2-course lunch meal exploring plating, presentation, and flavour
- A discussion with the chef regarding his role and the hospitality industry

Advance warning is needed of any participants with special medical, food allergies or other needs to ensure all health and safety considerations have been made. Parents must inform the school of any relevant medical or other needs on the visit consent form.
